Parish Councillor, A Tetley commented that the only possible work that may need to be carried out prior to installation would be in connection with the water supply. 4.7 It was agreed that councillors would suggest suitable locations for map boards and that L Beal would approach the Community Partnership Fund for funding. Authors of the Walking Maps leaflets are to decide whether to have the maps printed in book form or leaflets. The issue is to be discussed further at the July 2022 PC meeting.
