## **Public Open Forum**

Reports from County & District Councillors, Public Participation Session & Members Questions on these Items

- Councillor Mick Richardson will be emailing his Annual Report for the Parish AGM.
- Councillor Stuart Bird reported that the County Council has authorised £32M for Primary Schools. There will be a new Primary School in North Felixstowe and Trimley St Martin Primary School is to be relocated.
- £1.4M has been put towards Electric Vehicle (EV) charging stations. 100 EV charging stations have been provided by County Councillors across Suffolk.
- The project to replace 43K with LED lights has nearly completed. This scheme has already saved £2.5M in running costs.
- A query was raised about the white line painting. Only the most worn lines would be refreshed or repainted.
- The Chair raised a question about unanswered reports on the Highways reporting tool. The clerk will look into the numbers of outstanding reports for Councillor Bird to follow up.

#### 4. ITEMS FOR DISCUSSION

Action: Any articles for publication to Lynn Beal before 1<sup>st</sup> day of month before publication. June's edition deadline 1<sup>st</sup> May.

- **4.2** Colin Jacobs reported that the first map board was erected near the school by Stuart Last. The final location for the 2<sup>nd</sup> map board has to be finally agreed but will be in the environs of Searson's Farm. These colourful map boards commemorate the coronation of King Charles III.
- **4.3** David Southgate attended the Sports Council Awards. There were none for Trimley St Mary sports people this year.
- **4.31** The new Leisure Centre and Sports facility is being planned for completion in 2029 at an estimated cost of £35M and will be likely located off Candlet Way. Details to be confirmed in due course.
- **4.32** David attended a meeting with Norse 16<sup>th</sup> March. There are 7 x grass cuts of the verges per year for Trimley St Mary. The wildlife area off Faulkeners Way has 2 x cuts per annum in March and November.

Norse contracts finish 31 June 2023. East Suffolk Council bring that contract inhouse from 1<sup>st</sup> July to an ESC owned company called 'ES Services Ltd'

**4.33** Stennett Playing Field contract expired at the end of March 2023, this continues until 30<sup>th</sup> June when a new contract will be commenced until March 2024.

The Clerk raised that a late bill for grass cutting had arrived from Norse – the Parish Council agreed to pay this invoice of £2017.15. A further invoice for reseeding and top-dressing for £1367.00 was also agreed. See financial statement below.

- **4.4** The Speed camera (VAS) opposite Spriteshall Lane was recently vandalised. The Parish Council had an insurance claim settled for replacement with a like model and stat equipment.
- Speed camera £3,570.00 inc. VAT
- Stats measuring equipment £350.00 inc. VAT

A vote by Parish Council agreed to this purchase and replacement of equipment for the safety of Parishioners.

- **4.6** A comprehensive presentation about Neighbourhood Watch and its origins was given by Tony Allen and Sue Cox, NW and Parish residents. The benefits identified as about 10% reduction in burglaries and also reduces the fear of crime for residents especially the elderly.
- Tony Allen is retiring.
- Sue Cox will be the co-ordinator for Neighbourhood Watch for Trimley St Mary.
- A proposal was made to join up existing NW watch groups within Trimley St Mary to create one Neighbourhood Watch for Trimley St Mary, village wide to cover approximately 1700 homes.

A proposal to set-up a Facebook page for NW Trimley St Mary will be undertaken by NW co-ordinator.

The Parish Council agreed to support costs of the initial set-up of the village wide NW group:

- Signage
- Erection of signs
- Leaflets for a village wide leaflet drop
- A one-page advert to promote the scheme in the Spotlight magazine.
- Total pledged by the Parish Council to Trimley St Mary Neighbourhood Watch scheme was £1500.00.
- **4.61** Sue Cox will take on the co-ordination of the annual Christmas lighting up event in December. Procurement of a Christmas Tree and either planting/erection to be taken forward to the May Parish Council meeting.

Action: Clerk to investigate costs for a permanent tree and an annual tree.

- **4.7** King's Coronation event preparation update to be held on Sunday 7thMay 11:30am-14:30pm. The following list is of organisation to date. Purchase agreement is covered in the Financial Statement below. This is not a final list:
